

**Waiver and Release must be filled out completely to participate

In consideration of being allowed to participate in any way in the Youth Camp Ass. athletic/sports program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from the activities involved in this program is significant, including the potential from permanent paralysis and death and while particular rules, equipment and personal discipline may reduce the risk, the risk of serious injury does exist; and,
2. I knowingly and freely assume all such risk, both known and unknown, even if arising from the negligence of the releases or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with stated and customary terms and conditions for participation. If however, I observe any unusual significant hazard in my presence or participation, I will remove myself from participation and bring such attention of the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless, YOUTH CAMP ASS. their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessees of premises used to conduct the event ("release") with respect to any and all injury, disability, death , or loss or damage to person or property, whether arising from the negligence of the releases, or otherwise.
5. In addition, YOUTH CAMP ASS. its agents or employees, nor the owner assume any legal liability for items lost or stolen as a result of my participation within the facility.
6. I confirm that the applicant/participant has received a physical examination by a physician and has been found physically capable of participating in the soccer program and I have disclosed the participant's medial conditions, allergies, etc.
